05.3 Legislation and Advocacy - David Street

David reported as follows:

- The new Code and the additions to the Regulations (to implement section 14A of the Act) became law on 1 April 2015. Three sections of the Code (clauses 17, 18 and 19) will not become mandatory until the financial year commencing 1 July 2016. Further details of the changes are set out in the newsletter and the Code may be downloaded from the WARVRA website (warvra.org.au), see "Legislation" under the "Resources" tab.
- A reminder that the provisions in the Act and Regulations relating to the time cap on the payment of recurrent charges after a resident has permanently vacated the residential premises in the Village are now operative. To assist with monitoring this process, see the WARVRA website for a full explanation and a work sheet. Residents should check the village accounts to ensure that, if a former resident is no longer required to pay recurrent charges, the village operator is contributing an amount to the operating account in lieu of the former resident's contribution.

- Members should ensure that their family is aware of what has to be done when the
 resident leaves the village and that the family understands the provisions of the
 contract in regard to exit fees and charges.
- Electricity the Minister for Energy has confirmed that Regulations will be enacted to allow no supplier to charge more that the A1 tariff to Village residents.
